Dear Mr Walker, I have been passed your letter by Anthony Bush, our Parish Liaison and Rural Services Officer. I have also been in contact with your local ward member, Cllr Jinman, who had already relayed your concerns following his attendance at a recent parish council meeting.

Our regulatory officers are aware that there was a 'Sunrise Celebration' event last year at the Kentchurch Estate in August, which was licensed by Herefordshire Council under a Temporary Event Notice (TEN). This event was actually monitored by the Env Health Officers (EHOs) who attended at night time, this being flagged up before the event as a potential problem due to the late terminal hour for noise (03:00). Last year the env health team received only one complaint about the music level, although the officers who attended did not witness a statutory nuisance.

I am advised by the Licensing Team that last year's TEN was submitted in June, so we would normally expect this year's to be made at a similar time, although I am aware that the event organisers are currently seeking advice from the EHOs on noise management controls. Therefore an application may be imminent and clearly they already have a 2018 webpage.

If the application comes in as a TEN, then this will limit the numbers to a max of 499 at any one time, although this will relate only to the licensed areas (e.g. bar and/or stage audience area). The legislation permits the council to consult only with both the police and env health (noise) for TENs, so the parish council, fire & ambulance service and highways would not be consulted I'm afraid. However, if the organisers apply for a larger event through a temporary premises licence, then the list of consultees would be extended and the four licensing objectives would be applicable. The parish council would also be alerted in case they would wish to make a representation based on any evidence from the previous year.

We are therefore aware of this planned event and are aware that it was licensed under a TEN until 03:00 last year. We are also aware that the organisers might wish to grow the event and it is for this reason that the relevant officers have been made aware of your letter. A copy will also be passed to the police, as and when an application is made and consulted upon.

I hope this provides some reassurance that the council's licensing and regulatory officers are aware of this impending application and are working with the organisers to mitigate any problems that might arise.

"Dear Mark, Thank you for your recent email advising of this fallen tree. The Estate have cleared the immediate brash enable the footpath to be used but now wait for dryer conditions before carrying out any further work.

Our proposal is to clear away as much as possible of the tree to reduce it in size, but without causing any damage to the Scheduled Ancient Monument. Once we have reduced this tree so far as we reasonably can we will seek further advice from Natural England and Historic England on how they wish us to deal with the main trunk of the tree and the root ball. I am sure you will appreciate this may take some time. In the meantime, I hope that the work undertaken by the Estate to tidy up the brash and branches meets with the Parish Councils approval.

"Malcolm please could you circulate this to the Parish Cllrs of Kilpeck please.

I was asked if I would raise the closure of Hillside at full council on Friday. Before doing so I requested a briefing on the situation so I had a full understanding of what was being asked. The conclusion of which is the Council are not shutting the service down. The Building belongs to the Council, however the services offered on site are delivered by the Wye Valley Trust. The Trust are focusing their funding on Care at Home through the better care fund as they have results showing that treatment in the home far outweighs the this type of accommodation, therefore they have given notice and will vacate the building.

However, this building will not be boarded up, the cabinet member is currently in conversations and his team have organisations that wish to use the facility. As yet nothing has been confirmed, however this strategic state of the art facility will remain in use for community facilities.

I hope that answers your question, unfortunately the council cannot do anything to stop the decision by Wye Valley Trust, but I am assured that they have been challenged on their plans from the start by the council, who equally have concerns about this facility being shut.

Nuisance phone calls How to prevent nuisance phone calls

Nuisance phone calls come in many different forms. They are an invasion of privacy and can be threatening, abusive or obscene and may include heavy breathing or silence.

They may be random calls by pranksters or targeted calls by people known or not known to the victim, who intend to cause upset or intimidation for revenge, anger or humour.

How to deal with nuisance phone calls:

Don't give out the phone number when answering the phone.

Never give personal information out over the phone to an unknown caller.

If the call is malicious, try to remain calm as some callers gain pleasure from an emotional response.

Don't engage them in conversation, hang up immediately.

At the end of the call dial 1471 to see if the caller's number has been recorded - if it has, make a note of it and pass it to the telephone service provider.

Report all nuisance calls to the telephone service provider.

If the call was abusive or threatening, contact the police.

If the calls are persistent, the telephone service provider may suggest putting a trace on the line to gather evidence for the police.

The police will require evidence of the nuisance calls before they can prosecute.

Keep a log of all the nuisance calls - including the time, date and details of what was said

Service providers can provide a call barring system.

Alternatively, it may be worth changing the phone number.

Phone scams The police take phone scams very seriously. Criminals will often use scam phone calls as a way of defrauding people out of their money. On most occasions, people realise that the call is a scam, but we are encouraging people to continue be vigilant.

What to look out for:

Typically scammers will pretend to be from the police, and tell callers that their bank cards have been used fraudulently. Often the callers have stated that they are from the MET police, but they have been known to claim that they are from West Mercia Police, MI6 or the fraud squad. They will often say that they have the offenders in custody.

Usually they will then ask the victim to contact their bank to cancel their cards. In doing so, they will 'hold the line', so the victim believes that they are calling their bank, when in fact they are still on the line to the offenders.

They will then encourage the victims to hand over their bank details, including their PIN which they will often ask them to enter into the keypad of the phone.

Following this they will say that the cards are needed and send a courier to collect them. Sometimes they will ask the victims to give a password which the courier will use to make it appear more genuine. Consequently the offenders have been able to withdraw money from victim's accounts.

On other occasions, rather than sending a courier, they have asked the victims to transfer money to a secure police account, asking them to call back to verify that they are genuine, whilst holding the line.

Sometimes the scammers have told the victims to attend the bank to transfer money but told them that bank employees are involved in the scam, so not to mention it to them.

More recently callers have told victims that they are from Customs and Excise and that they have paid too much tax. In order to get this back they must pay an amount of money via a courier.

These scammers will often target those who are elderly or vulnerable. People with common surnames such as Jones or Smith tend to be targeted more often.

What to do:

We offer the following advice to protect you from these scams:



- Remember police officers, and banks will never ask for account details or PINs over the phone.
- Police officers and banks would never come to your house to collect your cards or property.
- They would also never ask you to transfer money to a secure account.
- If you receive a call like this, hang up immediately and call 101 using another phone. In an emergency or if a crime is in progress call 999
- If you have elderly friends or relatives who may be vulnerable to this scam, please talk to them and make them aware.
