However concern has been raised about the additional vehicle movements that this facility may generate as there appears to be no additional onsite vehicle parking and only limited parking in the adjacent layby on the A465.

The Parish Council would like to see some form of proposal which will improve the safety for vehicles entering or exiting the site onto the A465 which is sadly already an accident blackspot.

11.0 General Highway Issues for Report

To receive any Highway or Public Rights of Way for report

Councillor Mr N Eynon gave a report to the Chairman on the following:-

Salt Bins within the parish area had not been refilled by Balfour Beatty.

Bridge Farm bin and Church Lane Much Dewchurch Road junction empty, 2 x bins on Standard Lane (top of hill and bottom of hill) require filling.

He had checked the Parish Council's road salt/storage - everything satisfactory.

If Balfour Beatty will not fill salt bins, then Lengthsman to be instructed to do so

He also commented on the Black Mountain Quarries Planning Application {10/01/2018 number 174767} Stating that BMQ had purchase house, buildings and land, stone had been put down in the entrance to the lay-by, can the Clerk check the planning permission for the new entrance.

Balfour Beatty tipping hot box tarmac behind lay-by – do they have a licence for tipping waste materials.

Water running across the road above Duffryn Farm - Blocked small culvert under road – Skid Risk Clerk to report again

Howton alterations – no planning received – photographs to be sent to the Clerk of the cottage, mobile home, stable block and high fence.

Stiles require reporting again on Whitfield Estate - Photographs to be sent to Balfour Beatty

Much Dewchurch Road water on bend of road after railway crossing

Standard Lane water pouring down, constantly washing the surface away Mr James Howell Locality Steward to be contacted.

Information Greg and his father has done a wonderful job of litter picking on the A465 in the Kilpeck area.

15 year old Gregory Dunsford, from Belmont has been declared a Litter Champion by Herefordshire Council.

Gregory, from Belmont, started litter picking around his local area at the start of the summer and went out every day during the school holiday. Now he is back at school he is still making time to keep Belmont litter free and is out at least three times a week, no matter the weather.



"I litter pick around Belmont Pools and Haywood Country Park, as well as Waterfield Road and Westholme Road. I pick up sweet papers, beer bottles, cans, cigarette butts, bottle tops – basically anything that's safe to handle. I also report any problems I come across to the local councillor."
