9.0 A465 Road Safety Plan

To receive update and agree action required

Councillor Mrs J Davies Chairman had contacted the Chairman of Allensmore Parish Council Mr Tony Cramp, any information acquired by Kilpeck or Allensmore would be shared. Allensmore had tried a while ago but with no progress.

The Clerk had contacted Herefordshire Council and now the plans had been emailed to him. Also they had been printed and laminated 12 x A3 size. {Maps emailed to all Parish Councillors} Clerk had contacted Allensmore Parish Council Clerk Mrs Alison Wright and asked for their ideas reference A465 Road Safety Plans.

No reply as yet.

Kilpeck Parish Council will formulate ideas as well and then liaise when present conditions allow.

"Email received reference A465 safety issues

Re Road Safety message signage to hopefully make it safer around Kilpeck for walkers, pushbikes, horses, children etc. This is already partially approved but we might have to contribute to cost (they are similar to THINK BIKE yellow signs on A465 so not expensive & we could put them up)

I said provisionally Yes, he was discussing from St Devreoux / Dewchurch Road/ Marlas sort of area, but obviously depends what everyone thinks & would like ???

Do you think this would be a good idea???

Copied from and posted by Jane Manning. Should this not be an issue dealt with by the Parish Council."

"13th April 2021 Morning Christy,

I spoke to Jane Manning briefly on the phone last week and mentioned an idea I'm trying to progress with Wigmore Parish around getting some flexibility to develop the use a "road safety message poster". The attached email outlines the thinking. {see below} The issue she mentioned around vehicles rat running through the lanes between the A465 and Much Dewchurch has some similarities to the issue at Wigmore, hence why I mentioned the potential.

It's early days and there is no approval as yet....more of a workable concept, but the more support from other Parishes for something like this, means it stands more chance of happening.

It will have to be safely managed by us, as the last thing we need is hundreds of "random" posters appearing all over highway verges across the county, as that's a sure-fire way of devaluing their potential effectiveness and also making verges look unsightly. Kind Regards, Simon

"As part of an ongoing process that began last year following concerns expressed by Wigmore PC and Cllr Gandy, this is based around an idea to develop "Community Road Safety" message posters which should enable us to permit monitored usage by the Parish Council, to hopefully influence users on a local road through the Parish.



It originally stems from concerns raised around traffic on the C1019 through Leinthall Starkes which, whilst a lower category road, is a particularly busy back route (between Wigmore and Ludlow) with a high percentage of visiting traffic, due to a number of popular destinations such as Mortimer Forest amongst others. The original request to use additional signing presents issues with the appropriateness of standard fixed signing as found in TSRGD and the ability to use this correctly to influence behaviour in a realistic way (not to mention costs and physical space to actual get this in). In order to overcome these problems (and on the back of the Motorcycle Safety / Operation Snap / Community Speed enforcement posters idea we use annually with the Police), I initially suggested that the PC could try and develop a poster style idea that gives a cost effective solution (they would fund the manufacture) and we will work with them to ensure the safe implementation and develop a process for the future use of this type of measure (potentially) depending on the success. This is something

I have encouraged the PC to develop designs, based upon certain principles to ensure these remain a "poster" (not a road sign or using sign images found in TSRGD) giving more flexibility with their positioning, and help maintain an active "community presence" (which probably stands more chance of influencing / encouraging drivers to respect the local character and potential hazards) than standard road signing.

I'm happy that these latest versions of the designs present more of the "right feel", and with appropriate positioning, allow something to be done locally whist staying within the varying signing and planning regulation guidelines (where the tolerance for road safety message posters is originally mentioned around roadside advertisement etc).

Materials wise, the intention is these would be an A3 size Correx board enabling them to be zip tie mounted to appropriate existing street furniture, providing no additional structural hazard. Along with ensuring these do not obstruct visibility in inappropriate locations, there might also be potential to allow stand-alone version mounted on a suitable flexible / lightweight verge fixing (potentially a flexible hazard market post or lightweight timber batten type arrangement) that might allow greater options for verge mounting where existing street furniture does not exist (note this would NOT be fencing stake size as this would present too great a risk should it be collided with).

Allowing flexibility to alternate and change designs frequently (using those agreed) would also help reinforce to a familiar driver that this is something "active" and might help encourage more caution where needed.

Overall, whilst I can't give the ultimate "permission" to develop further, I would advocate the idea based upon my experience of similar concerns I've seen raised over the years in many locations (and witnessed the restrictions imposed by statutory signing regulations). I see this as a relatively low cost / effective method, that if managed appropriately, gives another tool to communities, and having recently discussed a similar concern with residents of Kilpeck parish, regarding rat-running in a lane off the A465, I suspect this might prove popular, and if so, something we can help standardise and administer effectively.
