Happy New Year to you all! I hope you managed to find time to relax with friends and family over the holiday period - I took extended leave over Christmas to spend time with family and friends from abroad, many of whom I had not seen before Covid. It was a very special time, especially for my children, however, as a result I do not have very much council business to report upon.

Budget Setting 2023/24 As reported at <u>Scrutiny</u> in September, the draft Medium Term Financial Strategy presents a challenging position with early forecasts identifying a gap between resources and pressures of £21.6m in 2023/24, rising in subsequent years to around £57m by 2026/27 if no mitigating actions are implemented. Public consultation was held over the Christmas period and closed last week. Scrutiny will be reviewing the current Independent/Green administration budget proposals next Tuesday 17 January with <u>papers</u> published this evening. This will be followed by a <u>Cabinet</u> meeting on 26 January before going to full council for approval on 10 February 2023. If you would like to attend or ask questions at any of these public meetings, please see how <u>you can get involved</u>.

Local Elections 4 May 2023 Local council elections will be held on 4 May 2023 and the pre-election period runs from 7 March to Thursday 4 May, 2023. The purpose of the pre-election period is to prevent announcements and activities by public bodies which could, or could be seen to, influence the electorate.

I will therefore provide my last update next month to ensure I do not breach any pre-election rules.

Unfortunately, I will not be re-standing as I am planning to move out of Wormside before the end of the year.
